

## **2025-2026 Description of Services & Fees**

**About Us:** This private practice clinic offers comprehensive assessments for children, teenagers and adults for ADHD and Related Disorders. We evaluate new patients of all ages. At this time, only California residents are eligible for new patient registration.

**New Patient Intake:** All prospective new patients are first screened with a brief intake form; a call can be arranged with our new patient coordinator upon request. If your needs fit our services, we will provide a packet for registration, and then help you schedule the initial 2-hour diagnostic evaluation that is scheduled on select Saturdays.

**Evaluations** for ADHD include a semi-structured psychiatric & diagnostic clinical interview with the patient face-to-face. New patients under 18 require at least one parent/legal guardian and family are welcome to attend for adults if present. All patients are assessed using nationally normed and validated cognitive measures for ADHD, executive function impairments, brief neuropsychiatric testing and screening for other related disorders. By the end of the appointment, your provider will share results of the evaluation, reserve time for psycho-education, and provide conversation or answer any questions or concerns. Your provider will also share personalized recommendations for treatment. Minors (under 18) need at least one parent present during the evaluation and adults are encouraged to bring a family member or close friend to provide additional perspective.

**Follow up Appointments** for treatment monitoring, psychotherapy, testing, cognitive-behavioral therapy and/or family meetings, established patients may self-schedule sessions using the Online calendar and billed according to the provider's hourly fee. Appointments are not pro-rated. If a longer session is needed, please contact your provider to request a 1-hour block of time.

**Testing & Report Writing for Accommodations:** For patients who request administration of additional diagnostic testing for other cognitive or psychiatric conditions, consult with your provider for this service. A separate appointment can be scheduled by our office after completion of the initial evaluation. Charges for preparation of a comprehensive written report of the initial evaluation, diagnostic letters and similar requests for written reports are billed separately by the hourly rate for the time needed for preparation, analysis and interpretation of the requested letter or report.

**Payment:** This office does not accept direct payment from health insurance, however we can provide you with a form (SuperBill) that patients may submit to your health insurance company for possible out-of-network coverage depending on your plan's policies. For all services, payment is due at the time services are rendered. We accept direct payment via credit or debit card, (including HSA/FSA), check, or cash.

**Rate/Fees:** Our initial evaluation fee (x2 hours) is billed for \$1,500. All other appointments are booked by the hour at a rate of \$260 per session/appointment.
